Re: Immediate Protection for Camp JTD and other encampments

EqualHealth - Campaign Against Racism:
Public Health and Medical Providers Letter of Support
For Camp JTD - Philadelphia, PA, USA

We, health workers and activists, stand in support of the residents of the James Talib Dean (JTD) encampments and affirm their right to take action to protect themselves and their loved ones during this unprecedented pandemic. The lack of adequate, safe, and accessible housing is a public health crisis that has spanned decades and is intensified due to the spread of COVID-19. United globally, as a community representing 23 chapters of EqualHealth's Campaign Against Racism across 9 countries, we call on the city to cease violent actions against the James Talib Dean Encampment (Camp JTD), and meet the material needs of its residents. It is a public health imperative that vulnerable populations have access to nutrition, shelter, and running water during this crisis in order to control the spread of infectious diseases and prevent unnecessary death.

The Centers for Disease Control and Prevention (CDC) have issued guidance against clearing encampments of unhoused individuals during the current pandemic, in order to ensure that people experiencing homelessness can live safely in the absence of other housing options.

The encampment is serving to mitigate the harms of a failing healthcare and housing system, acting as the only option for unhoused people to gain access to critical and basic necessities. By disbanding the encampment without providing a housing alternative to its residents, the city risks exacerbating the COVID-19 crisis in Philadelphia.

We demand that the city of Philadelphia take action to provide safe and accessible housing and support to the residents of the JTD encampments, and others throughout Philadelphia. The National Law Center on Homelessness and Poverty has documented more than 85 jurisdictions across the country that have placed people experiencing homelessness into individual units, including hotels, and vacant dorm rooms.<sup>3</sup> This action is not only feasible for the city to take, it is also crucial to the containment and prevention of the spread of infectious diseases including, but not limited to, COVID-19.

The City of Philadelphia has consistently failed its unhoused residents by refusing to provide appropriate and affordable housing to the community. The residents of Camp JTD are acting in defense of their lives by maintaining the encampment and providing basic and necessary structures for safer living while allowing members to participate in the urgently needed transformation of Philadelphia within a vision of the wider Black Lives Matter movement. In the absence of support from the city, Camp JTD has successfully arranged a food preparation area with the ability to receive, organize, prepare, and distribute donations, along with multiple sanitation stations including hand-washing units and a shower. Residents and volunteers run a medic station to distribute basic medications and supplies, as well as to coordinate access to emergency medical support, urgently needed COVID-19 screening, testing, and an additional hotel for high risk individuals.

As medical providers and healthcare workers, we support the demands of the Camp JTD residents as well as their rights to serve displaced and unhoused people by providing accessibility to healthcare, food, sanitation, COVID-19 prevention, harm reduction support, and ongoing community care. We call on the City of Philadelphia to cease any plans for violent actions to remove residents of this encampment or other encampments throughout the city, because this action will directly contribute to preventable deaths and poor health outcomes for already vulnerable populations.

The goal of EqualHealth's Campaign Against Racism is to dismantle structural racism and its effects on health around the world by supporting local actions, efforts, and networks which aim to improve the health and lives of those most affected by racism, because racism kills. Until the City of Philadelphia takes responsibility and meets the urgent material needs of its unhoused residents, most of whom are Black and Brown, all actions to disrupt the encampment will be racist and illegitimate acts, directly contradicting our public health advice. We await your response to these life-saving demands and look forward to meaningful action to meet the material needs of the residents of Camp JTD.
